2020 Financial Review - Treasurer Report - Chris Fowler

- Operating Accounts total account balance as of December 31, 2020 = \$47,000
- Net income gain/loss TOTAL GAIN in the amount of \$6,564.13 for the year of 2020.
- Operating account for 2020: Budgeted \$151,350.00 actual expenses used were \$155,287.87 over budget. Excludes gain in income
- **Reserve Account** total balance as of December 31, 2020 = \$44,798.47 Reserve account and North State Bank - CD \$47,561.33; \$92,000
- Operating Expense Summary 2020:
- i.1. Pond Maintenance expenses were over budget due to riser repairs.
- i.2. General Maintenance and Repairs over budget due to drainage repairs at the pool main drain covers.
- i.3. Pool attendant costs due to Covid-19 were in excess of budgeted expenses
- i.4. All Pool related expenses were over budget due to Covid restrictions.
- Net gain due to decreased operating expenses in the reserve fund for 2020 = \$16,013.44. Budgeted expenses for the year was \$28,000.00 and only \$11,986.56 was used. Gain of \$15,000 due to lawsuit settlement.
- There were no budget increases planned for 2021 and no assessments planned.
- Beginning balance: Operating Cash: \$40,000; Reserve: \$64,000.
- Becky added that the HVAC in the clubhouse was replaced in 2020 funds came out of operating fund.

Accomplishments of Master Board in 2020 – Jeff Hinkle

- ➤ Pool Opening under strict Covid-19 guidelines.
- Replace border and nets on beach volleyball court.
- ➤ Pond Riser repairs due to leak in riser. This was new issue from repairs in 2019.

- > Comments on the good job done by the ARC. ARC should be able to do site inspections later this year.
