Financial Report for 2022

- Operating Accounts total account balance as of December 31, 2022 = \$54,975.
- Net income gain/loss GAIN in the amount of \$41,000 for the year of 2022.
- Operating account for 2022: Budgeted \$172,972; actual expenses used were \$161,834 Under budget by \$11,000.
- Reserve Account total balance as of December 31, 2022 = \$236,241
- Operating Expense Summary 2022:
- Maintenance Tree, Pest, Irrigation were items that were over budget.
- Insurance expense was over budget.
- Net gain in the reserve fund for 2022 = \$38,762. Budgeted expenses for the year was \$46,800.00 and only \$8,361 was used.
- There were no budget increases planned for 2023 and monthly dues remain the same.
- Mention of new motors for pool, sunshades for playgrounds and pool, fish restocking, playground upgrade.
- Capital study referenced, to be renewed in 2024. Currently ahead of schedule on funds.
